At a meeting of the Board of Directors Meeting in November this year, W. H. Isaacs was appointed as the Club Historian to put together a document with items pertaining to Camp that would be of interest of present and future members. Per day rates were \$3.25 for members and guests paid for by members and \$4.25 for other guests.

The Club had an operating profit at the end of the year of \$130.51. This was great news to the group as the heavy spending in the past years had caused a loss before. Things were back on track.

The cooks, Horace & Jean Morin were hired again but this year the Camp had them sign a contract that outlined the duties and compensation paid.
